- Have completed at least five (05) similar projects during the last seven (07) years justified by certificates of good execution. (a similar project is defined by any achievement of at least one Flyaway station)
- Have achieved an average of turnover of at least 105 500 000,00 Algerian Dinars during the three years (2019, 2020 and 2021)
